We hereby inform you that the 122nd Annual General Meeting of Shareholders of Seiko Electric Co., Ltd. (the “Company”) (the “Meeting”) was held on Friday, March 27, 2026, and that reports were presented, and proposals were resolved as below.

### 2. Matters Reported

- (1) The Business Report and Consolidated Financial Statements for the Company’s 122nd Fiscal Year (January 1, 2025 - December 31, 2025) and results of audits by the Accounting Auditor and the Audit and Supervisory Committee of the Consolidated Financial Statements

### 3. Proposals Resolved

Proposal 1: Election of Nine (9) Directors (Excluding Directors Serving as Audit and Supervisory Committee Members)

The proposal was approved as originally proposed. Nine (9) Directors, namely, Messrs. Naonori Tsuchiya, Hidetoshi Soeda, Tsutomu Tanaka, Katsutoshi Arie, Kozo Ishida, Shigeyuki Takasaki, Ms. Reiko Aoki, Mr. Katsumi Inazuki and Ms. Akiko Kato were elected, and they assumed office.

Four (5) Directors, namely, Messrs. Kozo Ishida, Shigeyuki Takasaki, Ms. Reiko Aoki, Mr. Katsumi Inazuki and Ms. Akiko Kato are Outside Directors.

Proposal 2: Election of Three (3) Directors Serving as Audit and Supervisory Committee Members

The proposal was approved as originally proposed. Three (3) Directors, namely, Messrs. Hiroshi Niuro, Katsunori Takada, and Masatoshi Tanaka were elected, and they assumed office. Two (2) Directors, namely, Messrs. Katsunori Takada and Masatoshi Tanaka are Outside Directors.

Note:

By a resolution passed by the Board of Directors at its meeting held after the Meeting, Mr. Hidetoshi Soeda was elected Representative Director, and he assumed office.
